Fund Commentary

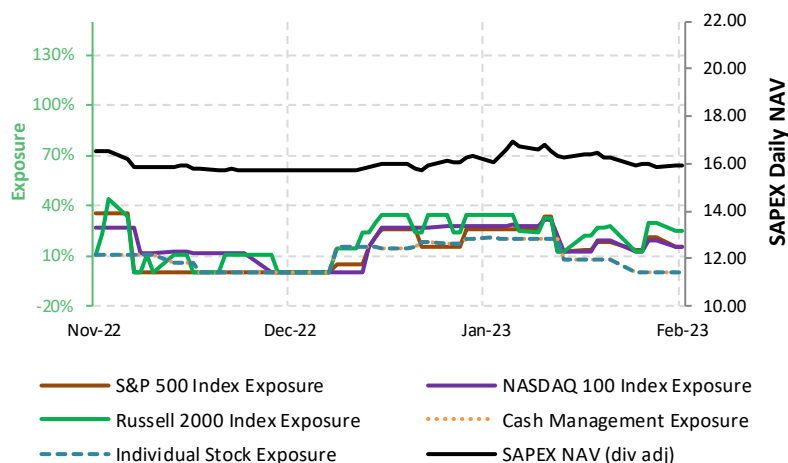
February can be characterized as a time of consolidation for the major equity indexes. More specifically, a portion of the gains made in January were given back though volatility remained generally low as compared to levels seen during most of 2022. A modest decline in equities after a swift rally can be healthy, though caution is still warranted when monitoring specific nearer-term technical methodologies, waiting for signs of a return to strength. The Spectrum Active Advantage Fund (SAPEX) expanded and contracted exposure tactically while momentum swayed throughout the month. The macro pattern remained in more of a jagged basing attempt rather than an established uptrend. Management is encouraged by longer-term improvements in equity market breadth though chart patterns and indicators need more work before the overall environment is considered bullish.

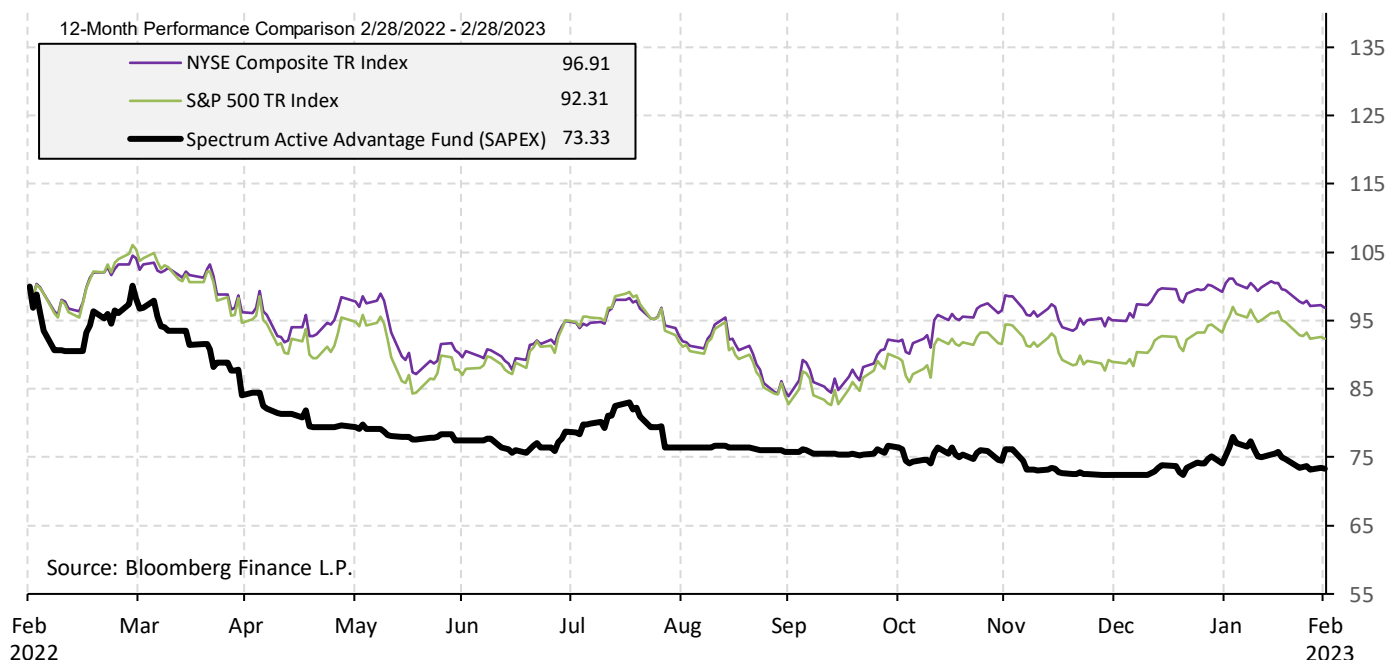
