Fund Commentary


Equities faltered in February as investors adjusted to the uncertain outlook brought about by the assertive trade tactics of the new administration. Small and mid-cap indexes faired worse, as major indexes fell below key technical levels such as their 200-day moving averages. Large-cap stocks such as those in the S&P 500 Index and NASDAQ 100 Index performed well early in the month with both having set new 52-week highs before pulling back in the latter half of the month. SAPEX entered February leaning more toward larger caps, including investments with traditionally defensive/lower beta characteristics. Overall exposure was reduced in the latter half of the month as momentum weakened across the board in an attempt to balance overall exposure with investments maintaining positive trends.
