


The Spectrum Low Volatility Fund Update **Fund Commentary**

Bond and equity markets experienced a heightened level of volatility in what some are calling the "Tariff Tantrum." Treasury yields began the month at year-to-date lows and within days, were at their highest levels since January. As the month progressed, President Trump delayed some tariffs and touted progress in talks with trade partners. The less aggressive tone likely played a role in easing the bearish sentiment. Perceived economic speedbumps led investors to express beliefs that the Federal Reserve may have counter measures with several rate cuts this year as odds of a cut in June are above 60%, as implied by Fed Funds futures. Amid market volatility and a murky outlook, the Hundredfold Select Alternative Fund sought the safety of cash early to mid-month in most investment sleeves, leaving exposure at one point in just a small gold and a market neutral holding. Exposure later ramped up quickly as markets displayed signs of washout with favorable risk/reward characteristics. Bond categories such as government, quality corporate, securitized credit and high yield were added. Given the ongoing crosswinds, a long/short equity fund was also added.



The chart above shows how the Fund performed against related sector indices for the past 12 months. The Fund focuses on domestic fixed income and credit markets, but can invest globally when prudent. The management team navigates the various bond classes and their specific characteristics. Various bond classes tend to move in different directions from each other, as some tend to perform better when there is economic growth while other classes perform better during times of heightened instability. The Fund's holdings and exposure can shift on a daily basis allowing it to be nimble. Spectrum's core philosophy is to achieve competitive returns without sacrificing the goal of risk management.
