

The Spectrum Low Volatility Fund Update

Fund Commentary

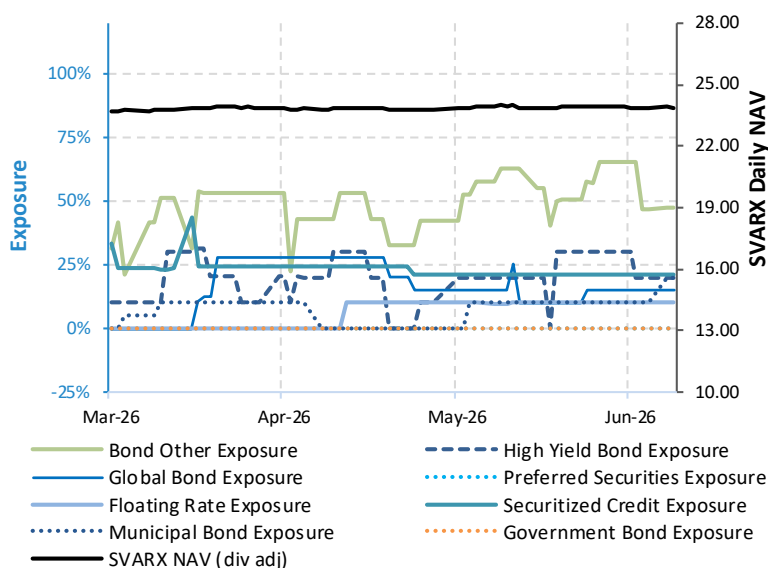
Following the June FOMC meeting, new Fed Chair Warsh made hawkish comments that led investors lowering the odds of rate cuts during 2026. Stronger anti-inflation rhetoric helped bond prices rise and rates decline during the month although the path was rather jagged. While this provided support to most bond classes, some fared better than others. A rising U.S. Dollar created headwinds, more so for foreign bonds, though not enough to completely alter trends. Treasury yields remained choppy as stronger labor data and inflation concerns kept markets focused on the Fed's policy path. Municipal bonds continued to draw steady interest, while credit markets held up despite heavy issuance and tighter spreads. The Spectrum Low Volatility Fund (SVARX) adjusted exposure throughout the month before ending near the beginning of the month levels. Modest rotation took place as municipal bonds were added and foreign investment positions were trimmed.

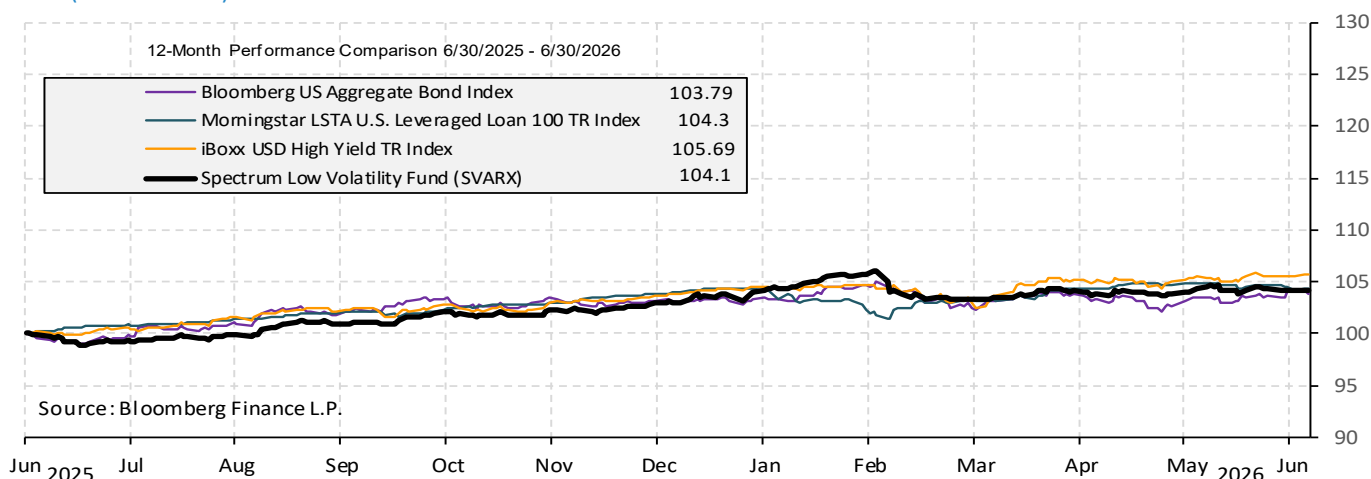

SVARX (Fixed Income) vs. Sector Indices



The chart above shows how the Fund performed against related sector indices for the past 12 months. The Fund focuses on domestic fixed income and credit markets, but can invest globally when prudent. The management team navigates the various bond classes and their specific characteristics. Various bond classes tend to move in different directions from each other, as some tend to perform better when there is economic growth while other classes perform better during times of heightened instability. The Fund's holdings and exposure can shift on a daily basis allowing it to be nimble. Spectrum's core philosophy is to achieve competitive returns without sacrificing the goal of risk management.
