

The Spectrum Active Advantage Fund Update

Fund Commentary

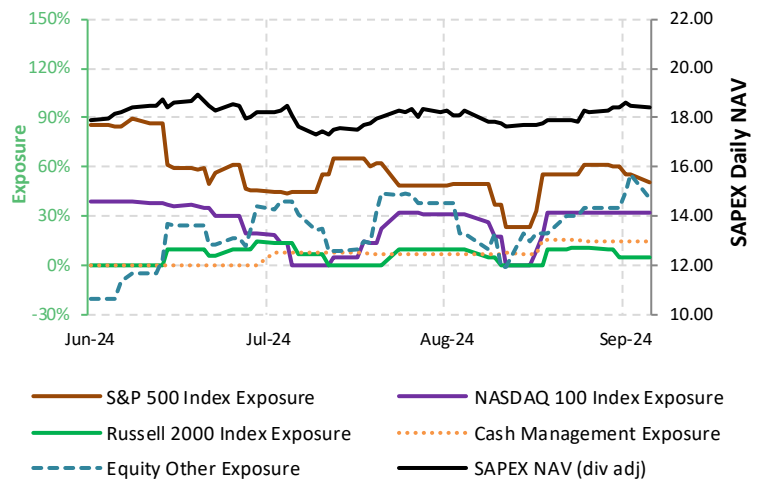
Equity markets were jagged in September though the major averages were able to post positive returns. Weaker action early in the month had the Spectrum Active Advantage (SAPEX) take defensive measure only to quickly add exposure mid-month as chart patterns improved. Outperformance by the S&P and NASDAQ 100 over the broader-based NYSE showed that market participants favored larger cap stocks over mid and small caps. Late in the month, the major indexes were in consolidation patterns within their macro uptrends. A falling rate environment historically is risk-asset favorable but SAPEX’s management will monitor trends and the stall patterns for destabilization or upside resumption as investors position ahead of the election and growing global headwinds.

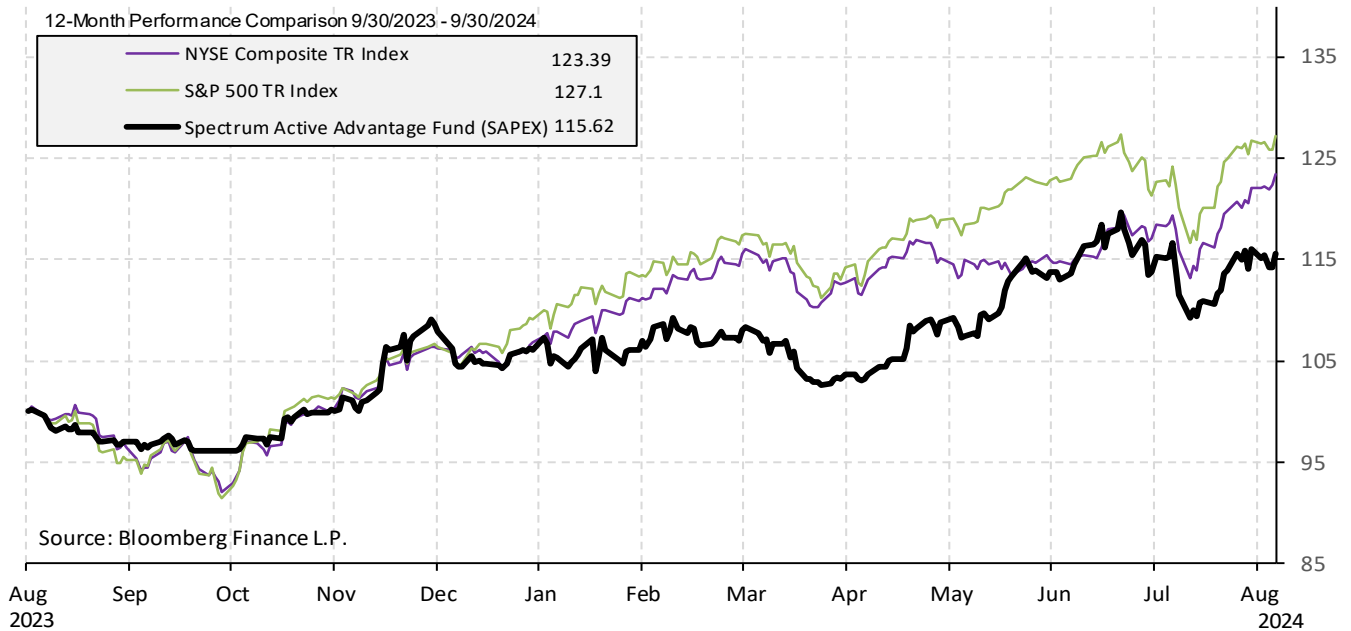
